Legislative Report

The fall veto session concluded with the adoption of a new budget. This budget provides more to TRS than was required, however, legislation to insure proper notice of changes to health insurance has not yet been adopted and will be taken up again in the next legislative session. SB 250, as amended, became the budget, and it appropriates \$50.618 billion in General Revenue Funds and assumes revenue of \$50.717 billion. The budget allowed for \$200 million more than the statutory payment for pensions (of which approximately \$100 million will go to TRS. The Budget fully funded the statutorily mandated payment for health insurance, albeit at the lower rate that CMS established for this year.

HB 3504 120 day's notice requirement for changes to TRIP/TRAIL. This legislation was an initiative of IRTA to make sure that individuals are given notice of changes to their healthcare at least 4 months prior to those changes being implemented. Ultimately, the General Assembly was consumed with saving the community college health insurance fund from bankruptcy and chose not to address TRIP or Trail this year; however, we will be continuing this conversation into the next legislative year.

SB 1468 extends the sunset until 2026 for returning to work for up to 120 days or 600 hours. This provision, although in law for over a decade, was set to expire at the end of this year.



Are you looking for Dental and/or Vision Insurance for you and/or your family? You can purchase each insurance separately or together.

The dental plan for IRTA is covered by Ameritas Life Insurance Corporation. Coverage for the dental plan includes:

- Use of the dentist you want or select a dentist within the Ameritas Dental
- Network and save up to 50%
- No waiting period
- You can access providers nationwide
- Routine cleanings 100% covered
- Routine oral exams 100% covered

\$50 calendar year deductible per person for GOLD and \$100 deductible per person for PLATINUM. \$1000 calendar year maximum per person for GOLD and \$1500 calendar year maximum for PLATINUM

The price for coverage for GOLD is \$40.41/member per month, \$80.84 monthly for a member plus 1, and \$102.05 monthly for a family. The price for coverage for PLATINUM is \$69.25/member per month, \$138.51 monthly for member plus 1, and \$174.86 monthly for a family.

The eye insurance plan emphasizes eye health from independent, private practice VSP eye doctors. Coverage for the VSP plan covers both in and out of network. It includes:

- Exam covered in full once every 12 months after a \$15 co-pay
- Prescription glasses obtained after a \$25 co-pay
- Frames covered up to \$150 once every 24 months and lenses fully covered
- every 12 months
- Contact lenses covered once every 12 months

The price for this coverage per member is \$12.72 per month, \$22.30 monthly for a member plus 1, and \$27.75 monthly for a family.
